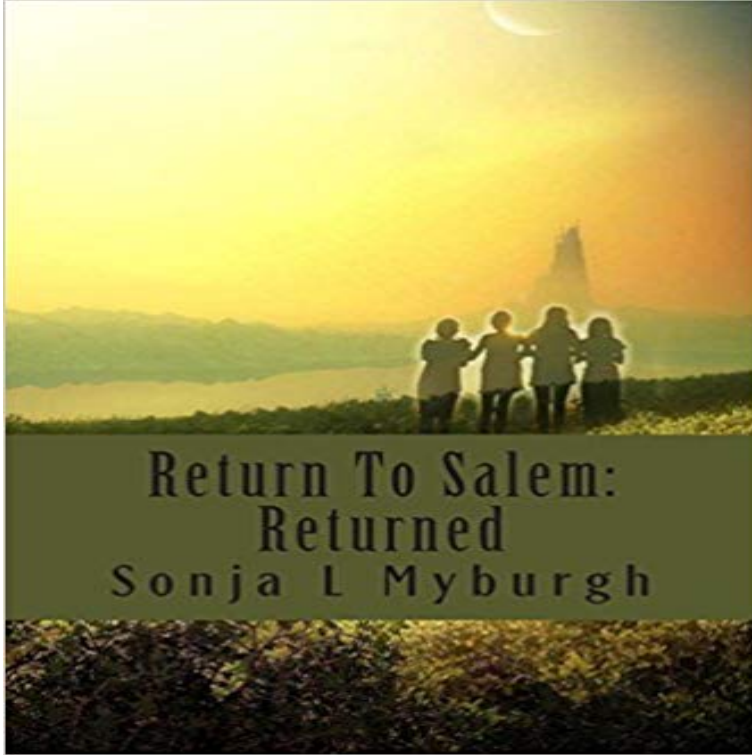


# Return To Salem: Returned (The Return Collection) (Volume 1)
